## Required Inspections Information

In order for the permit to be compliant with the Minnesota State Building Code, required inspections must be completed by the Building Official. This shall include the required inspections listed below for each relevant work type. Failure to request required inspections will result in absent inspection records for the property including a lack of inspection documentation for insurance claims and real estate purposes. **Please request all required inspections as provided below.**

All required inspections should be scheduled by contacting (507) 388-4224. Requests can be made Monday – Friday, 7am – 7pm. and Saturday, 8am – 1pm. Inspection requests should be made not less than 24 hours in advance. Same-day in-person inspections may be available but are not guaranteed. Same-day remote virtual inspections are offered for most express permits and can be scheduled in 1 – 2 hours. Eligible inspection types are provided below.
